**What data do we collect through our website?**

We process data collected by the use of cookies. Such data may include sites visited on our website, sites visited through our website and the duration of the visit on our website. **What are the purposes of processing data obtained through our website?**

Data that we collect by use of cookies may be processed for the following purposes: statistics, demographic data identification and data on the interests of the website users, but without the possibility of user identification; We also process data to diagnose problems on our servers, administer our website or for other purposes that you asked for or agreed to, unless the law provides for otherwise.

**Cookie files (cookies)**

A cookie is a small file that is saved on your computer when you first visit a website. The website which sends it recognises its cookie when the website is visited again. The purpose of this technology is to work to improve our website and your user experience.

The cookies we use are session cookies (they expire when you close your browser). Session cookies are used to count the number

of visitors of our website. We also use third party cookies from other sites: these are YouTube cookies (allow certain video content to be played on our website), advertising cookies and Google Analytics cookies that we use to understand how you navigate our websites, what content you are interested in and what is the duration of your visit. Based on them, we can edit the content of our website and adapt it to the needs of our website visitors.

We process data collected by use of cookies only for statistical purposes and to identify demographic data and information about the interests of our website users (but always by the use of methods that do not allow to identify a specific person). We also use them to diagnose problems on our server, to administer our website and to provide information about our products.

Most web browsers automatically allow cookies. You can opt-out from receiving cookies at any time.
